Executive's Assesment



Aforestation Program for Protecting Environment

Subah Samajik Unnayan Sangstha (SSUS) has been implementing the aforestation program beside the rural roads including Meherpur-Chuadanga high road since its inception. The program has been extended widely with the financial help of Bangladesh NGO Foundation from 2008.

It is required to protect the environment for a sustainable earth.

The world environment is now in the face of threat that is why inhabitants of the earth are anxious. The climate of the world is being changed, environment is polluting for over population, limitless using of natural resources, destruction of trees, excessive vehicular movements, industrialization that creating global



warming, greenhouse effect, increasing of sea level. As a result different natural disasters like deluge, draught, cyclone etc. are increasing alarmingly. Inequality is found in changing seasons in the country. Crop production is being hampered due to incessant rain

fall and no rain fall in proper time.



In order to ecological balance it requires 25% percent forest of total land but our forest is not more than 15%. As and when any development program is materialized there is every possibility an adverse impact on the environment. That is why SSUS imposes more and more importance for

the development of environment as and when it implements any development program. Considering the state of affairs, SSUS encourages people of all the communities for plantation.

SSUS's slogan is "Elimination of poverty through protection of environment and development". That is why SSUS has been implementing forestation program extensively in order to removal of the poverty and protect the environment by using the local resources properly.



Health, Nutrition and Population Control Program

Bangladesh is a over populated country. The health services are inadequate be it government or non-government level in comparison to needs. The unaware and poor people are deprived of necessary health services. As a result they are dependent on village healers and unscientific systems. Subah Samajik Unnayan Sangstha (SSUS) is trying to remove such problems after indentifying the basic humanitarian problems.



Abreast the other programs of SSUS, it continues the Health, Nutrition and Population Control program since its opening. Stakeholders are getting health services from specialists and experienced physicians free of cost and awareness on health, nutrition and

population control. SSUS has been providing with the health service to the grassroots level since long.



With the financial support of Health and family welfare ministry this organization gives health services and distributes medicines free of costs at grassroots level. Medical camping, courtyard parley for awareness buildup on health, nutrition and population control and distributing of balanced diet to children under the program.

SSUS organizes seminar on health, nutrition and population control off and on.

Basic Literacy Program(64 District)

This organization has completed the Basic Literacy Program(64 District) in Gangni upazila in Meherpur district in the month of June, 2020 starting from August, 2018. Through the program a total of 18,000 illiterate male and female upto age group 15 to 45 through 300 learning centers.



"Development of sanitation system in small ethnic groups and extremely poor families" program

In Meherpur Sadar Upazila, Amjhupi Union, Amjhupi village, Ward No. 7, there are about 65 families living in the area. All these poor families do not have sanitary latrines and defecate in open spaces and unhygienic latrines. The area is defecated in unhygienic toilets and open spaces that pollutes the environment. Due to environmental pollution, various diseases spread. Subah Social Development Organization conducted a baseline survey to identify the 27 poor families in the project of providing hygienic semi-pucca toilets in the special allocation of 2019-2020 financial year in Bangladesh NGO Foundation.

Name of Program : Vulnerable Group Development(VGD) Program

With assistance of Women Affairs Directorate under Women and Children Affairs ministry of Bangladesh Government this organization is being implemented VGD program in 11 Union Parishod of KumarkhaliUpazila under Kushtia District. The VGD program is the largest social security program of the government, which is aimed only at improving the living standards of female members of rural extremely poor families. In Kumarkhali upazila of Kushtia district, 2,147 women are getting food assistance (life skills, income generating training,

savings and loan opportunities every month). The program is being implemented by Subah Social Development Organization.



Smoking and Tobacco Control Law Implementation Program

Being the associate member of Anti Tobacco Alliance SUBAH has been working since 2000. From 2005 this organization is being implemented different programs in the sadar upazila of Meherpur district relating to tobacco in order to implement the Tobacco Control Law. To speed up the activities this organization implements more works with the support of WBB Trust like tobacco control law monitoring, establishing of smoking free sign, distribution of leaflets, stickers, holding of advocacy meetings with the stakeholders.

SUBAH SHAMAJIC UNNAYAN SHANGSTHA, a non-government, non-profitable, non-political voluntary organization initiated by the like minded young stars in 1998.
